



Dear Customer,

As you may be aware, effective February 1, 2022, Westlake Chemical Corporation (renamed since as "Westlake Corporation" and referred to hereinafter as "Westlake") completed its acquisition of Hexion's Epoxy business (which, as a global Westlake business unit, has since been branded as "Westlake Epoxy"). Hexion's U.S. Epoxy business was previously run through the US legal entity "Hexion Inc." with which you have traded in the past. In September of 2021, in advance of the sale of Hexion's Epoxy business to Westlake, Hexion contributed its U.S. Epoxy business to its wholly owned subsidiary Hexion Coatings and Composites (US) Inc. ("HCC"). On February 1, 2022, the shares of HCC were sold to Westlake as part of the sale of Hexion's Epoxy business.

Since February 1<sup>st</sup>, 2022, and as part of the transition, Westlake Epoxy has been able to continue using the name "Hexion" to conduct business through HCC until it could transition fully to reflect the new ownership of the company and the new name of Westlake Epoxy.

Today we are happy to inform you that, effective April 15, 2022, the legal name of HCC has been changed to "Westlake Epoxy Inc."

Please note that this new name will only be reflected on our documents as from May 1, 2022 since the cutover of our systems will only occur on that date.

**This means that starting on May 1, 2022:**

- All purchase orders that you used to place with Hexion Inc. should be placed with Westlake Epoxy Inc. Orders placed before this date do not need to be changed and will be handled as usual.
- All purchase orders that you place will, unless otherwise contractually agreed, be subject to Westlake Epoxy's terms and conditions of sale. These T&Cs remain substantially similar to Hexion Inc.'s and are located at <https://www.WestlakeEpoxy.com/en-gb/company/legal-notices/terms-and-conditions>, but we recommend you re-familiarize yourself with these T&C's.
- The documents you will receive from us (e.g., order confirmations, invoices) will reflect the Westlake Epoxy Inc. name and logo.

**What do I have to do?**

You will need to update your vendor set-up to correctly reflect the name of Westlake Epoxy Inc.

**At this moment there are no other changes. Our address, VAT number, bank account number, phone numbers, email addresses and contact persons will not change. Any future changes will be communicated to you separately.**

We are committed to continuing to provide excellent customer service, and we thank you in advance for your co-operation and patience during this transitional phase.
